21	Cause process. In recent years, requests for Orders to Show Cause, whether
22	captioned as "motions" or "applications," have been considered ex parte
23	although such treatment is not described in court rules. The Family Court Bench
24	is concerned that this practice has been a source of confusion for lawyers and self
25	represented litigants. The practice has also required judicial officers to hold
26	hearings or to issue orders in order to obtain the views of non-moving parties. In
27	an effort to make practice reflect existing court rules, the Family Court Bench
28	orders that all requests for order to show cause; whether captioned as "motion,"
