It is hereby ORDERED as follows:

- 1. Judge Deborah Schumacher shall serve as the Presiding Judge of the Family Division of the Second Judicial District Court. See WDCR 2(4); WDCR 30(1)(a).
- Judge Linda Gardner shall continue her administrative responsibilities over Domestic Violence. See WDCR 30(1)(e)(1).
- 3. Judge Frances Doherty shall continue her administrative responsibilities over Juvenile Delinquency. <u>See WDCR 30(1)(e)(2)</u>.
- 4. Judge Egan Walker shall continue his administrative responsibilities over Child Support Enforcement (UIFSA). See WDCR 30(1)(e)(3). Judge Walker shall also continue serving as the adult guardianship judge as contemplated in Administrative Order 08-05.

- 5. Judge Deborah Schumacher shall continue her administrative responsibilities over Juvenile Dependency. See WDCR 30(1)(e)(4). Judge Schumacher shall also continue serving as the minor guardianship judge as contemplated in Administrative Order 08-07.
- 6. Judge Chuck Weller shall continue his administrative responsibilities for Mental Health/Developmental Disability Involuntary Civil Commitment. See WDCR 30(e)(5).
- 7. Judge Bridget Robb Peck shall continue serving as the presiding judge over the Alternative Dispute Resolution Program. <u>See</u> Administrative Order 09-04.
- 8. Judge Connie Steinheimer is designated as the Probate Judge for the Second Judicial District Court, and Judges Steven Kosach and Jerry Polaha are designated "Probate Backup Judges." See Administrative Order 09-02. Judge Steinheimer shall also continue serving as the presiding judge over the Short Trial Program. See Administrative Order 09-04.
- 9. By separate order, the Chief Judge has confirmed Judge Patrick Flanagan as the Foreclosure Mediation Judge. See Administrative Order 2012-2.
- 10. Judges Brent Adams, Patrick Flanagan, and Bridget Robb Peck shall serve as
  Business Court Judges within the Second Judicial District Court. See Administrative Order 09-03.
- 11. Judges Connie Steinheimer, Chuck Weller, and Egan Walker shall be ex-officio trustees of the Washoe County Law Library Board. <u>See</u> NRS 380.020.
- 12. The Chief Judge shall assume supervisory and administrative responsibilities over the Grand Jury.
