13 PRESIDING JUDGE ADMINISTRATIVE ORDER 2018-02

14 WHEREAS, the Second Judicial District Court Chief Judge has authority to
15 make administrative decisions pertaining to the business of the Court (*see generally*
16 *WDCR 2; see also NRS 3.025(2)(c)*);

17 WHEREAS, the Chief Judge has appointed a Presiding Judge of the Family
18 Division, who shall serve at the pleasure of the Chief Judge and shall perform such
19 duties as are delegated by the Chief Judge (*see WDCR 2(4)*);

20 WHEREAS, Administrative Order (AO) 2018-16 was filed on October 1, 2018,
21 and required reassignment of a portion of the Department 14 workload;

22 WHEREAS, Supreme Court Rule (SCR) 48.1(9) provides that “[n]otwithstanding
23 the prior exercise of a peremptory challenge, in the event that the action is reassigned
24 for any reason other than the exercise of a peremptory challenge, each side shall be
25 entitled, as a matter of right, to an additional peremptory challenge;”
