15 **ADMINISTRATIVE ORDER 2021-07(A)**

16 **[RESUMPTION OF JURY TRIALS – CIVIL DOCKET]**

17 **[POPULATION OF TRIAL STACKS]**

18
19 WHEREAS the Second Judicial District Court (“SJDC”) Chief Judge has authority to make
20 administrative decisions pertaining to the business of the court (WDCR 2(2), NRS 3.025(2)(c)) and
21 incorporates all recitals set forth in Administrative Order (“AO”) 2021-07 as if set forth in full here;
22

23 WHEREAS AO 2021-07 establishes the Trial Stack (“TS”) Model for SJDC civil jury trials,
24 pursuant to AO 2020-02(E), and sets forth TS numbers and dates for civil jury trials through 2022;
25 and,

26 WHEREAS the TS model established during the COVID-19 pandemic to facilitate the
27 resumption of civil jury trials is a temporary measure. Civil jury trials will be conducted pursuant to

1 the TS Model, until and unless the Chief Judge orders civil jury trials will be conducted under the
2 Assigned Department model.

3
4 **Accordingly, and good cause appearing therefor, this Administrative Order 2021-07(A)**
5 **follows:**

6 The SJDC populated the TSs with civil matters presently set for jury trial during 2021- 2022.

7 As populated and set forth this AO, the TS Assignment Grid is a “snap shot,” of all civil jury
8 trials set as of the date of preparation of this AO. The TS Assignment Grid changes day to day based
9 on new trial settings, dismissals and granted motions or stipulation for continuance. The TS
10 Assignment Grid will be updated at designated intervals and the SJDC is currently working on
11 posting the TS Assignment Grid, as it is updated, on the SJDC website.

12
13 Each TS set forth below is not prioritized. In other words, the following TS Assignment Grid
14 lists the civil jury trials within each stack but does not reflect the order in which the trials within the
15 TS will proceed.

16
17 Subsequent AOs will set the prioritization of the individual TSs.
