ADMINISTRATIVE ORDER 2024-01

WHEREAS the Second Judicial District Court (“SJDC”), as part of the state constitutional judicial system, “has the inherent power to protect itself and to administer its affairs.” City of N. Las Vegas ex re. Arndt v. Daines, 92 Nev. 292, 294, 550 P.2d 399, 400 (1976);

WHEREAS the Chief Judge of the SJDC has authority to make administrative decisions pertaining to the business of the Court (WDCR 2(2), NRS 3.025(2)(c));

WHEREAS the Chief Judge shall assign cases to each judge in the judicial district (NRS 3.025(2)(a));

WHEREAS certain presiding judge, dockets, committee and liaison assignments are necessary to effectuate the orderly administration of justice within the SJDC to further foster consistency, efficiency and fairness.

Accordingly,

IT IS HEREBY ORDERED:

1. The Case and Committee Assignments reflected in the attached Exhibit A shall be effective immediately and shall transition as practicable. If an assignment has

1 been made to a new judge, the new assignee and the prior assignee will work together
2 with staff regarding a commencement date.

3 2. This Administrative Order 2024-01 replaces Administrative Order 2022-04.

4 3. Interim additional District assignments may be made by the Chief Judge as
5 necessary. And,

6 4. This Administrative Order shall remain in effect until further Administrative
7 Order of the Chief Judge.
